## **LIMITED WARRANTY**

All warranties are subject to the warranty of the original manufacturer. Fimco Industries' products are warranted for one year from date of purchase against manufacturer or workmanship defects for personal or homeowner usage. Fimco Industries products are warranted for 90 days for commercial users. Any unauthorized modification of a Fimco product will void warranty. Warranty claims will be processed by Fimco Industries after the items are returned freight prepaid to the Fimco Industries location where the product was purchased. Examination and determination of warranty, if applicable, will be subject to and limited by the warranty of the original manufacturer. Fimco Industries assumes no liability for any unwarranted equipment. All items must be returned within 30 days of failure.

## **LIQUID CARRYING VESSEL WARRANTY**

Liquid carrying vessels are subject to the applicable warranty only. The loss of chemicals within the vessel is not covered by warranty. Expenses, inconveniences or other damages that may occur are not subject to warranty consideration. The warranty is void if the vessel or vessel lining failed because of inadequate support of the vessel, misuse or lack of reasonable care or use of chemical formulations not recommended by the vessel manufacturer. The user shall check all labels for the information on known chemicals that are detrimental to vessel or vessel lining. The user shall determine the suitability of the product for his intended use and assume all risks and liability in connection therewith. The entire limited warranty is embodied in this writing. Fimco Industries neither assumes nor authorizes any person to assume for it any other liability in connection with its equipment.

## **RETURN FOR CREDIT**

Merchandise may be returned for credit only upon authorization by Fimco Industries. Upon authorization, merchandise must be returned freight prepaid within 30 days of purchase. All returns must specify the invoice number and the date the items were purchased. Credit will be issued for the net invoice cost less all allowances, freight charges, a handling charge and additional charges for any items not received in saleable condition. The final credit issued, in any event, will be subject to Fimco Industries inspection to determine condition.

## **CHECK MERCHANDISE IMMEDIATELY UPON RECEIPT**

If a shipment is received in bad condition or there is a shortage, note this fact on the carriers receipt. Report any problems to Fimco Industries immediately.
